NOTICE CAN BE "TRICKY"

One of the elements required to prove a workers' compensation claim is showing that the employer had NOTICE of the work injury. But what exactly is notice and who is supposed to get notice?

When an employer has an injury/incident log or requires that a report be completed when an injury occurs, that is notice. Previously, written reports were required for the Bureau on a specific form, but now many employers simply contact their compensation carrier and a FROI or First Report of Injury is filed on line with the Bureau; the injured worker never sees this or knows it is done. That report does not even resemble a report of injury! If the employer requires the injured worker complete a report before going for treatment or to document the incident if treatment is refused, a copy should be requested. Perhaps a policy could be negotiated where providing the injured worker with the report is a requirement for HR. This document helps to prove notice and as an employer form, may be admissible into evidence.

If there is no specific report form, an injured worker is cautioned to report the injury to the appropriate representative of the employer. Telling a co-worker, and even a union rep, is not sufficient notice if a representative of the employer is not informed. There should be someone designated for those reports by the employer. In times when employers had a plant dispensary or nurse, that individual was given notice of injuries. Now, with remote working or plants across the country, it is difficult at

times to know WHO TO TELL. It is essential for there to be some policy in place designating the appropriate party to receive notice, and workers should be aware of that person—even if it is an HR representative a thousand miles away. Telling everyone in the authority chain at the workplace can be sufficient, and should be under the Act, as that is informing a representative of the employer—but people "forget" or get transferred or don't file the report to HR and then proving notice gets complicated and that proof is on the employee. Injured employees should write down WHO they told WHEN they told them and WHAT they said, so that when called upon to testify, that information is available and can counteract "faulty memories" or "lost" reports.

Notice should be given as soon as possible after the injury. The Act provides a period of up to 120 days from the date of injury to provide notice, but the sooner the better makes for easier proof. Some employers require notice within 24 to 48 hours and say that notice not given within that time means that the claim is "no good." That is NOT TRUE, as the Act provides a far more significant notice period. HOWEVER, reporting within that time period is best, not simply to comply with the employer's rules, but because the longer an injured worker waits to give notice, the greater chance that issues will arise or that details might be forgotten. An injury occurring on Friday should always be reported on Friday, even if it means calling a "hotline" provided by the employer or slipping a note under the HR

rep's door—if not, the claim is usually questioned by employers and carriers when reported the following week: there seems to be an assumption by those parties that "something happened over the weekend" and now the employee is trying to make it work-related. Long holiday weekends make this defense even more likely, and injured workers find themselves pursuing litigation where it just doesn't seem it should be necessary.

Please understand that "actual knowledge" by a representative of the employer is notice—so if a supervisor sees it happen or is called over immediately, that is—and should be—enough. However, memories fade and people "forget" so it is always best to document the incident, even if the owner of the company is standing there—maybe ESPECIALLY if the owner is standing there?

Notice seems so straightforward. However, cases have been lost because injured employees did not tell the "right" person or an accident report was "lost" and so on and so on. As the workplace becomes more spread out or people are working remotely, and HR is no longer in the building, notice might become even more "tricky" than it has been in the past. It is essential to understand that without proper notice a claim fails. All workers should recognize its importance. Then, in the event of an injury, they can make certain they know the steps to provide this essential element of their burden of proof.

Virtual Phone Banking During This Election Cycle

The use of electronic media this election cycle will be paramount if we are to be successful in electing labor friendly endorsed candidates. But some of you fear the unknown and unfamiliar process of using electronic media at a time when we desperately need your help to succeed.

Let us assure you it is not that difficult. In this article we will compare the process and then break it down in several easy steps for you.

Many of you have done conventional phone banking:

- We used our cell phones or land lines and called from paper lists and utilized a script we had a hard copy of in front of us.
- As we completed our calls we documented on a sheet the results (not home, wrong #, refused, left message, or if we actually talked to them their status already voted, supporting or opposing our candidate, and willingness to volunteer.)
- After we finished someone scanned or entered our records into the system(LAN) and then reports could be run to determine how well we were doing and the likelihood of success.
- Sometimes the data entry was delayed and it may have impacted the campaign.
- When all of this was done we still had to shred these confidential records.



In reality, the process is really similar and improved by technology. Let us explain:

- Your paper list is now electronic and viewable on the computer screen (we can adjust the size of print if needed), (no more printing of lists thus reducing costs and expediting of the process),
- Another change is the list on the computer is broken down by families and each screen contains one family (no more checking the lists of names to see if the next one on the list has the same phone number),
- A given screen may have more then one individual and they may each have a land line they share and their own cellphone numbers, thus improving our opportunity for successfully reaching our members resulting in more completed calls and thus a more successful program.
- The script is on the screen with each call (no more looking for the script you know you had before you moved the papers),
- The documentation is still done on the list but instead of writing it you simply push a button to select the appropriate response. (no more fumbling if the pen drops or runs out of ink)
- When you have completed all the calls possible from the current screen simply hit the "save and next" button on the screen and the next screen for another individual or family appears.
- The data is entered as we make the calls (no more scanning in or entering of your results and no need to shred the confidential records),

- The data from your calls are immediately accessible to those analyzing the progress and making the decisions for days ahead.
- We still encourage all volunteers to leave a message if you get an answering machine,
- You can make calls at your convenience from 9am to 8pm any day you have time,
- You can call from your home or office thus you know it will be safe and you don't have additional travel thus reducing the amount of personal time used for your activism,

Now that you realize it is not so difficult, we hope you will reach out to your Central Labor Council and speak with the Labor 2020 Program Coordinator and volunteer to help.



To begin making calls; grab your cellphone or phone, sit down to your computer, log into the LAN, utilizing the log-in and password given you after a brief training. Select the virtual phone bank for your area or as instructed, read the script, practice saying it out loud a few times and begin making your first call.

Remember you are only calling Union households in a modeled universe of your union brothers and sisters some of which may be retired.

We appreciate all that you do and ask for your help during this election cycle. We have only 24 days left until Election Day, please help!!!

APPLY FOR SOCIAL SECURITY DISABILITY BENEFITS

In order to apply for Social Security Disability benefits, you can apply online at http:// www.socialsecurity.gov or apply in person at your local Social Security Administration "SSA". When filling out the application, it is important that accurate information concerning the names and addresses of all your treating physicians is provided. Additionally, all medical impairments for which you have sought treatment should be listed, not merely your most severe impairments. SSA must consider ALL of your health conditions in evaluating whether you are entitled to Social Security Disability benefits.

After you file an application for Social Security Disability benefits, SSA will begin contacting your treating physicians in order to obtain medical records. You may want to obtain in writing, to submit to the SSA, the opinion of one of your treating physicians as to the nature and degree of your disability, with that physician clearly stating your course of treatment and any specific limitations you may have. The opinion of a treating physician that you will be disabled for a period of twelve (12) months or longer will greatly increase your chances of being approved for benefits.

I also suggest you make sure the SSA is able to obtain all records pertinent to your medical conditions. Very often, the SSA Know Your Rights! will either not seek records or not be able to obtain records from all of your medical providers. Therefore, you should inquire as to what records they have received, and try to obtain and send to them any other records you feel are important in assessing your disability status.

During the time SSA is in the process of evaluating your claim for benefits, you should be sure to return any phone calls <u>promptly</u> and to attend any appointments for evaluation they schedule for you.

If you are denied benefits, you should immediately contact SSA's office, as you will have only sixty (60) days in which to file an appeal of Social Security's Decision. Failure to file an appeal within that time frame may result in your ability to file an appeal being lost forever. You may wish to have an attorney file the second step appeal for you.

If the SSA grants you benefits, you will receive a Notice of Award letter thereafter, indicating the amount of monthly benefits you should receive.

Lit Drop

- •Volunteers who choose to do lit drops:
- The Pennsylvania AFL-CIO will provide all materials needed for this program

- Lit drops will require no face-to-face contact and would simply drop off information that is important for our members to know regarding the Labor 2020 program
- Masks/shields/PPE must be worn

Canvassing

- Volunteers who choose to do door knocking to evaluate members and provide information voting and endorsed candidates need to adhere to the following guidelines:

- If knocking doors for conversations with members, must adhere to sixfoot social distancing—knocking and walking away from the door at a minimum of six feet to engage member in conversation

Labor 2020 Persuasion Canvass Script

This script serves as a guide to talking with union members like yourself about what is at stake with this year's election. The key to talking with members about our endorsed candidate, Joe Biden, is to connect with them and hold a real conversation. With that in mind, please read through the tips and script, but make the script your own.

The left-hand column provides instructions. The right-hand column includes the suggested script. It would be best if you did not read this script verbatim. Gauge the conversation and comfort level with members and don't do anything that makes you or the member feel unsafe.

Tips on Persuading Voter

You can use a talking point or share your personal story with a member voter who is undecided or doesn't support Joe Biden for President. Here are some tips for telling your personal story:

- 1. Challenge: Focus on one personal challenge you are facing or have faced; what was the impact of the challenge, and why did it lead you to support Joe Biden for President?
- 2. Policy: Focus on one policy position that Biden holds that would address your challenge.
- 3. Workplace: How has the current administration impacted your workplace? What would it mean to have a pro-union candidate in the White House?
- 4. Union: How has the current administration affected your union or the union movement? How would that change if we unions had a friend like Joe Biden in the White House?

WHY IS UNINSURED AND UNDERINSURED MOTORIST COVERAGE IN YOUR AUTOMOBILE POLICY IMPORTANT?

Uninsured and underinsured motorist coverage, also referred to as UM and UIM coverage, is one of the most important parts of your automobile insurance coverage. Yet, Pennsylvania law does not require that you carry this coverage, so it might seem like a waste of money. But not purchasing these benefits could place a high financial burden on you or your family members if you are involved in an accident with an at fault driver who does not have the necessary liability coverage. Nationwide as many as 13% of drivers do not have any automobile insurance. Add to that the risk of getting injured by a driver that has very little insurance, and you will want to make sure you purchase UM/UIM coverage. In Pennsylvania, drivers are only required to purchase \$15,000/\$30,000 in bodily injury coverage. This means that if you are in an accident that is the other driver's fault and that driver carries the minimum coverage then you can only collect up to \$15,000 from their insurance company even if your injuries are catastrophic. If more than one person is injured as a result of that negligent driver, there would be \$30,000 available but this amount must cover all those injured whether that is 2 or 10 people. As you can guess, this minimum coverage is often not enough to provide compensation for even relatively minor injuries.

To ensure you have the right coverage to protect you and your household family members, you should make sure to carry UM/UIM coverage. If you have purchased this insurance and you are involved in an accident with a driver who does not carry sufficient insurance to compensative you for your injuries or who has no insurance whatsoever, you can file a claim with your own insurance company for UM/UIM benefits.

If your insurance policy covers more than one vehicle, you should also consider stacking your UM/ UIM coverage. What this means is that if you have \$100,000 of UM/ UIM coverage and you have three

by Kelly Enders and Susan Meredith vehicles on your policy with stacked coverage, you will have \$300,000 of UM/UIM coverage available if you are in an accident with an uninsured or underinsured motorist.

What if you have more than one automobile insurance policy in your household, can you stack the UM/ UIM coverage between the policies? Due to a recent decision from the Pennsylvania Supreme Court, the answer is now Yes. You may have two policies in your household because you own a motorcycle as well as cars or because a relative living with you has their own automobile insurance policy. Before Pennsylvania Supreme Court in 2019 decided the Gallagher v. GEICO Indemnity Company case, if you were involved in a motorcycle accident that was the fault of another driver who had no insurance or insufficient insurance, you would most likely have only been able to collect UM/UIM benefits on your motorcycle policy. The available UM/UIM coverage on most motorcycle policy is often only \$15,000.00. The Gallagher decision invalidated an exclusion that the insurance companies had been using for many years to deny their insured's UM/UIM claims on other motor vehicle policies in a household.

To understand what this means, consider the following example: A son who lives with his parents owns a car and has his own policy that provides for UM/UIM coverage of \$15,000. His parents also have an automobile policy and have purchased stacked UM/ UIM for their 2 vehicles for available coverage of \$200,000. The son is involved in an accident in his own car with a driver who has insufficient coverage to compensate him for his serious injuries. He can claim UM/ UIM benefits on his own policy, but he can also make a claim for UM/ UIM benefits under his parents' policy because he lives with them. This could allow the son to access \$200,000 of UM/UIM coverage over and above his own \$15,000 coverage that was not previously available to him prior to the 2019 Gallagher decision.

This new rule allowing UM/UIM claims on multiple polices in a household can be applied to accidents that occurred as far back as 2015, depending on certain factors. If you were involved in a motorcycle or car accident in the last four years where you collected UM/UIM benefits under a policy of insurance and either had multiple motor vehicle policies under your name that provided UM/UIM coverage or had a family member living with you who had a separate policy with stacked UM/UIM coverage then you may be able to claim additional benefits. There are time limits to bring these claims so please contact the attorneys at Caroselli Beachler & Coleman immediately if you think you may be entitled to additional benefits.

To fully protect yourself and your family against uninsured and underinsured drivers, you should make sure you have sufficient UM/ UIM coverage and that such coverage is stacked. You should purchase as much UM/UIM coverage as you can afford. We recommend a minimum of \$100,000/\$300,000 with the stacking option if you are insuring more than one vehicle and as always select the Full Tort option never the Limited Tort option.

The amount of time and content provided by the CLC administrators of a Union Hall website will be much less than you may anticipate. Your websites will have content provided through syndication form the AFL-CIO, your State Federation, and your Area Labor Federation. This will help keep your website current and you need only add the local information, events, actions, and etc., as needed.

Your Union Hall website can and should be customized/ personalized for your CLC by branding with the inclusion of your CLC logo, connecting it with your social media sites, like Facebook, Twitter, YouTube, and more.

The AFL-CIO offers FREE training via ZOOM and the NWPA ALF will also help with one-on-one training as needed.





The two images below depict the front and back of the envelope containing your mail-in ballot. Watch for it!








On the left below are the instructions included with your ballot. A snippet is above. Remember to vote for all the races, the ballot is printed on both sides.

Once you have completed your ballot, put it in the envelope pictured below.



Seal the envelope above and place it in the envelope pictured below.



Turn the envelope above over seal it and complete the information requested, see the image below. Either mail it or deliver the sealed envelope containing your mail-in ballot to your Local County Voter Registration Office or their Election Drop Box. Note: There are 2 boxes to be checked on the flap of the envelope.

 Mark your Ballot. Fill in the oval next to your candidate with a black marker or pen. For write-in candidates neatly print his/her name on the line provided and darken the oval.



2. Pack and seal your ballot.

- a. Put your ballot in the "Official Election Ballot" envelope and seal it.
- **b.** Put the "Official Election Ballot" envelope in the Business Reply return envelope and seal it.



 Sign and Date it. Fill in the Voter's Declaration on the Business Reply return mail envelope. Make sure to Sign and Date it.



4. Return your ballot. By Mail - No postage necessary. Ballots must be received by 8pm November 3, 2020. The PA Supreme Court ruled that ballots postmarked November 3 will be counted if we receive them by November 6, 2020.

Alternatively, PACK AND SEAL YOUR BALLOT AS DESCRIBED ABOVE and bring to the Voter Registration Office Room 112 of the Erie County Courthouse, 140 W. Sixth Street, Erie, Pa 16501 or use the Secure Drop Box located out front.

If you receive an absentee or mail-in ballot and return it by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your ballot by the deadline, you may only vote a provisional ballot at your polling place on election day <u>unless</u> you surrender your ballot, and Business Reply Return envelope to the Judge of Elections. They will void your ballot materials and let you vote by regular ballot.
