# Labor Council Adopts "Unions For All" **Endorsement Principles**

The Beaver-Lawrence Central Labor Council has adopted SEIU's 2020 "Unions for All" election agenda as principles to be considered when making endorsements during the 2020 election cycle. The Labor Council adopted a resolution supporting the agenda at the Labor Council's January membership meeting.

SEIU unveiled the agenda to its membership at a "Unions for All Summit" attended by 1000 of its members in Los Angeles. The summit was held in October. SEIU International President Mary Kay Henry called on the presidential candidates who spoke at the summit to support the agenda.

A copy of the Labor Council's resolution is printed below. Primary election candidates seeking the Labor Council's

endorsement and attending the Labor Council's candidate interviews on March 7<sup>th</sup> should carefully review the four principles of the resolution.

The Labor Council's "Unions For All" resolutions reads as follows:

vision of an America where all working people can join together in unions and earn at least \$15.00 an hour: where quality healthcare is accessible and affordable for all and everyone has a secure retirement; where immigrant families are able to stay together: where all communities have access to quality public services; where we dismantle anti-black and structural racism and people regardless of gender or sexual orientation; where every vote counts; where we all have clean air to breathe and clean water to drink; and where our economy and democracy work for all of us, not just millionaires and billionaires; and

WHEREAS working people united in the **Beaver-Lawrence Central** Labor Council demand that 2020 candidates unabashedly champion eco-

**RESOLVED** that the Beaver-Lawrence Central Labor Council will consider the following principles of Unions for All when making endorsements in the 2020 election:

1. Everyone in America should have guaranteed access to quality, affordable healthcare and long - term care. And all healthcare jobs should be good, union jobs. On a path to universal healthcare coverage, we must invest in and improve the Affordable Care Act. Medicaid. Medicare, and long-term care. This includes empowering the dedicated workers who provide essential, compassionate healthcare and home care services to join together in unions, raise wages, and improve job and service standards.

2. Immigrant families should be welcome, safe, and free in America. Immigrant workers are powerful leaders in our union and integral to the care and service workforces in this country. Instead of tearing immigrant children from their parents, inciting division and spreading fear, we must extend relief to Temporary Protected Status holders, take care of Dreamers, and enact common sense reforms that provide a clear path to citizenship for hardworking immigrants, prioritize worker protections and family unity, and are consistent with our core values as a nation.

3. We must take immediate, bold action on climate change, hold corporations responsible for rampant pollution and accountable for the shortterm and long-term implications that it creates, and create good, union jobs in a just transition. Policies to combat climate change must be connected to those that raise standards for all working people and address the needs of communities of color who are most impacted, so that no workers, families, or communities are left behind.

4. We're committed to winning \$15.00 an hour and a union for all working people – black, white, and brown – and using our powerful voice as organized labor to hold politicians accountable to fight alongside us. It's time to embrace a new future in which anyone who wants to join a union in their workplace can, no exceptions. And it's time for those who have been elected by working people to fight alongside us, no exceptions.

### **Carpenters Local 420 Support UAW Local 1311 Strikers**

In Langeloth, a small community outside of Burgettstown, Washington County, the nearly 100 members of UAW Local 1311 have been on strike for nearly six months. They have

maintained their picket line on top of the hill through the fall, then winter, now nearly spring. On February 8<sup>th</sup>, the Carpenters of Local #420 answered UAW President Jim Hall's open letter request in the Union Bug by delivering nearly \$800 in supplies.

As we stood on the picket line, it was obvious the strikers had the support of the community, just as passing travelers waved and honked – strikebreakers entered the gates to start their shift. Their license plates were as varied as the passerby, Ohio, Pennsylvania, West Virginia, Texas.

Our opposition being so varied, our resistance should be likewise. If the management at Langeloth Metallurgical, like ATI Midland before them, are willing to bring in strikebreakers, it could be the fate of any of our locals to face them on the picket line in the coming years.

All member unions should be encouraged to reach out to our brothers and sisters in Langeloth, and support them as they are able, as what happens in Langeloth will have an effect on Beaver and Lawrence Counties and beyond.

## PRO Act Passes U.S. House 223-193

Pa. AFL-CIO Februarv 6<sup>th</sup> Press Release

This week the U.S. House of Representatives passed H.R. 2474, Protecting the Right to Organize Act lurgical have done danger-(PRO Act). [Editor's Note: The bill must be passed by the Senate and signed by the President or a presidential veto overridden bv Congress before it becomes a law.] This is the most significant and advancing piece of Labor Law Reform legislation to move in decades. The PRO Act would:

Repeal right to work laws;

Provide for first contract arbitration;

Speed up elections;

Stronger remedies for violations, including civil penalties (up to \$50K)

Ban permanent replacement of strikers;

Permit secondary picketing;

Card Check as a remedy for employer interference;

Ban Captive Audience meetings; and,

Narrow the definition of supervisor and close the independent contractor loophole.

The PRO Act would have a significant impact on workers across our Commonwealth. Workers like our are no longer an effective union brothers and sisters at *means for working people to* Langeloth Metallurgical.

For generations, the workers at Langeloth Metalous and difficult jobs to process molvbdenum and strengthen American steel. These men and women have been on strike since September 9th for the most fundamental right of every worker, the right to be safe on the job. But on January 6th, the company brought in permanent replacement workers. The PRO Act would ban permanent replacement workers.

This is an exciting time in the labor movement as more and more workers exercise their voice at work and want to join a union. The PRO Act in the Federal government and the Pennsylvania Workers' Bill of Rights in our own state government are just two examples of Labor's fight for working people

National AFL-CIO President Richard Trumka made the following comments on the PRO Act's passage:

"I applaud the U.S. House for passing the PRO Act. Make no mistake, this is the most significant step Congress has taken to strengthen labor laws in the United States in 85 years and a win for workers evervwhere.

America's labor laws have our voices heard. The long-overdue PRO Act will provide significant protections for workers exercising our legal right to form a union, a right that's been trampled on for decades by union-busting consultants and anti-worker politicians.

The PRO Act is the labor movement's number one legislative priority this year for a reason. Working people are hungry for a bill that will ensure a process for reaching a first contract once a union is recognized. prevent the misclassification of employees, protect the right to strike and so much else. America is ready for more unions: and a happier. healthier and upwardly mobile workforce will help reverse the inequality of income, opportunity and power that is threatening our families, our communities and our democracy.

This bill is for working people - and President Trump's veto threat, though replete with inaccuracies and distortions, speaks volumes about who he is really fighting for. But our movement is bigger than any party or politician, and we will not rest until the PRO Act is the law of the land and the rights of workers are restored!"

PPG Services is a paint services platform that poses risks to the wages and working standards of workers across North America. The

IUPAT is convinced that the PPG Services' model threatens to exploit working people and their families with predatory pricing that jeopardizes fair wages and health and retirement benefits.

At noon, over 100 lead-PAT. community allies and elected officials demonstrated with banners and leaflets in Pittsburgh's historic Market Square. As the group educated consumers on the issue, they also asked America.

The program will feature a screening of a documentary, "POWER TO HEAL", that tells the story of how Medicare was used in the 1960's to mount a dramatic, coordinated effort that desegregated thousands of hospitals across the country in a matter of months.
