The NWPA ALF per capita payment of \$0.37 per member per month is paid on the number of dues-paying members within our jurisdiction. Affiliates may pay per capitass; monthly, quarterly, semi-annually or annually in advance. Per capita is due on the first of each month. If per capita payment for any month is not paid by the first of the following month the local union shall be deemed in arrears. Please call 814-360-8336 if you have any questions on this statement. If you are not the correct person to be receiving this statement, your help in correcting our records would be appreciated.

### ARREARS NOTIFICATION

According to our records, the per capita payments for your office are in arrears. Beginning 1/1/20, if an affiliate becomes three months in arrears it shall not be in good standing and not entitled to voice or vote in meetings of this Area Labor Federation and the CLC's we serve. An affiliate that becomes four months in arrears shall stand suspended from membership and shall be notified in writing. Notice of this suspension shall be sent to their International and respective Central Labor Councils.
