SEIU Brighton Rehab Update

My name is Denise Cox and I am an Internal Organizer for SEIU Healthcare PA. I represent eight long term care facilities for our union. I presently am the organizer that represents Brighton Rehab. Currently there have been over 70 residents who have succumbed to the COVID virus. Around 100 of our members have contracted the virus and thank God they have all recovered.

The biggest take away from this pandemic er staffing to give quality care. and the experiences we have had with our nursing homes has been devastating. Our members become family to the residents that are in their care. They are also the ones who are there when the residents take their last breaths comforting them because the families are not permitted into the facilities.


After our experiences during this trying time, we realize now more than ever our nursing home issues need to be on the forefront of changing the industry.

The nursing homes and hospitals have not received an PPE assistance from the federal government. Often times our members are given rain ponchos to wear because of the lack of accessibility to gowns and also wear a mask for numerous days.

Our union has been fighting to improve the ratio's that the state has put into place that directly affects staffing. Currently the Commonwealth of Pennsylvania requires a resident to receive 2.7 hours of care in a 24 hour period. This is an archaic ratio and doesn't allow for the prop-

Also the funding for nursing homes has remained flat making it harder to get substantial raises when we get to the table. Short staffing has also let to staff leaving the field because of sheer frustration and years of physical toll the job has taken.

The virus has helped to shed light on a broken system and our hope is that we can use this as a catalyst to fix a broken system for the workers that we represent and the residents in their care.

It has certainly been a long and troubled time with this pandemic. As we are slowly relaxing the restrictions, there is still a lot of suffering and strife. The unemployment rate is still off the scales, and the virus is still not done with us. The food banks and food kitchens have been over whelmed due to this, but there is one organization that could use some much needed help.

The YMCA has been a great place to belong to. Most people do not know that the YMCA supplies meals to churches and other organizations that distribute to the community. Before the pandemic, they made around 5,000 meals a month. They are now making around 8,000 meals a week according to Aaron Bingle, the food services director. This is very problematic because they are presently not open to the public, which means that the membership is down.
