Secretary-Treasurer Piasecki announced the effort at the Labor Council's monthly meeting held on Februarv 20th at the PSEA Building in New Castle.

PA AFL-CIO State Director Chuck Green attended the meeting with Secretary-Treasurer Piasecki.

The handout distributed by Secretary-Treasurer Piasecki at the meeting states that: "our new Labor education, communication and mobilization network will allow affiliates to stay informed and engaged on legislative issues that affect our members at the workplace and daily lives.

Starbucks Workers To Hold One Day Strike, **Call For Picket Line Support**

March 22nd is Starbucks "Founders Day," which Starbucks has chosen to use as a celebration of outgoing CEO Howard Schultz. Rather than allow Starbucks to continue lying to the public about being a progressive, we're going to make this day one where we put on full display that our working conditions need major improvements by coordinating a nationwide strike across 150 union stores. Our strike will be an illustration of the powerful community that we have built as Starbucks workers.

The date is also one day before Starbucks Shareholders Day, which gives our strike addi-

tional leverage because we'll create pressure on the company immediately before their investors convene to discuss the health of their brand. By striking at 150 stores on March 22nd, we will be demonstrating for the incoming CEO and other Starbucks executives that we are able and willing to create a crisis for them that they can only resolve by settling a contract.

Starbucks workers will strike and picket seven Starbucks stores in the Pittsburgh area on March 22nd. We call on our union brothers and sisters and our community allies to join us on our picket lines that day. Picket lines will be manned until 3:00 PM at the following locations:

The Allegheny-Fayette Labor Council then tweeted that it is "grateful to all the union members and elected officials who came out to stand with us. We will not be silenced and we will sure the hell will not be intimated.

Dear Representative,

The undersigned are writing to express our support for the inclusion of former House Resolution 192 (2021-2022) into the adoption of the 2023-2024 House rules when the chamber reconvenes on February 21. This effort would expand workplace protections against acts of sexual harassment for those who advocate on behalf of their causes or communities before members of the Pennsylvania House of Representatives.

In 2019, the House took the critical step of expanding sexual harassment protections for House employees. Legislators changed House rules to establish a process for employees to raise complaints of sexual harassment to the House Ethics Committee. Following an investigation validating the complaint, the House Ethics Committee is empowered to recommend reprimand, censure, expulsion or limitations on privileges.

Former House Resolution 192 expands those protections by removing the limitations on the Ethics Committee process. Rather than limiting the investigatory process to only employees of the House, the process would be available to anyone who experiences harassment from a House member while they are engaging in official duties or while in a House owned or leased facility.

The limits of this effort are obvious; it does nothing to protect against discrimination based on race, sexual orientation, or gender identity. It cannot protect every worker in the state against workplace sexual harassment.

However, how the House chooses to govern itself is a message to every workplace and employer in the state. It sets a standard to which the Commonwealth should hold itself. Passing this resolution would tell anyone who comes to advocate before the House that they will be protected from harassment, and that their safety is of the highest concern.

We urge the adoption of this new House Rule when the chamber reconvenes on February 21.
