## STRIKING P-G WORKERS RECEIVE **GOOD NEWS AS THE LONGEST ONGOING WORK STOPPAGE IN AMERICA CONTINUES**

Workers striking the Pittsburgh Post-Gazette received good news on several fronts this holiday season as they continue the longest ongoing work stoppage in America.

The workers, from the Newspaper Guild of Pittsburgh (NewsGuild-CWA 38061), Pittsburgh Typographical Union (CWA 14842), Pittsburgh Mailers (CWA 14847), and Press Operators (PPPWU), have been on strike against the Post-Gazette since October 2022 because of several unfair labor practices by the company, including bad faith bargaining, illegal declaration of impasse, illegal imposition of work rules and surveillance.

The National Labor Relations Board on

(e) emergency injunction in the Third Circuit Court of Appeals in Philadelphia on behalf of the Newspaper Guild, the union that represents the PG's newsroom employees. The injunction would, if granted, restore the union's previous contract and compel the company to bargain a successor agreement in good faith, in addition to a variety of other actions that could help end the strike. A date has not been set for a judge to hear the case.

\* A quorum being present, the delegates


approved the expenditures made by the Executive Board.

## **President's Report**

The AFL-CIO and the Service Employees International Union (SEIU) have announced "that they are reuniting to launch a new, long-term effort to make it easier for workers to win a voice on our jobs with their unions." The official announcement was made on January 9 at a roundtable discussion held in Austin. Texas. in advance of the AFL-CIO's Martin Luther King, Jr. Civil and Human Rights Conference. SEIU and several other international unions withdrew from the AFL-CIO in 2005 to form the Change to Win federation. The AFL-CIO permitted Change to Win local unions to remain in AFL-CIO central labor councils. The SEIU locals affiliated with the Beaver-Lawrence CLC, SEIU Local 668 and SEIU Healthcare PA, continued their participation in the Labor Council. In July 2016, the Labor Coun-

cil and its affiliates were well represented at the rallies sponsored by SEIU Healthcare PA as it fought to negotiate a fair contract with the Heritage Valley Health System in Beaver. The Labor

Council has supported Healthcare PA's efforts to secure fair contracts at local nursing homes. We stand ready to help SEIU Local 668 when called upon by it to help settle a fair contract for Local 668 members working in the Beaver County Courthouse. SEIU Local 668's predecessor, SEIU Local 585, played a key role in the revitalization of the Labor Council in the 1980's in response to the Reagan administration's attacks on the Labor Movement. It helped mobilize local participation in the historic 1981 Solidarity Day March on Washington in response to the firing of PATCO members and the 1983 March on Washington to commemorate the August 28, 1963, March on Washington for Jobs, Peace and Justice. It also helped arrange a congressional hearing in Aliquippa on full employment legislation in response to the closing of many steel industry plants in the early 1980's. Welcome back SEIU into full participation in the AFL-CIO. We must work together as closely as possible when the new presidential administration takes office on January 20.

### **REP. DELUZIO INTRODUCES LEGISLATION** TO TRANSFORM RAIL NETWORK

Thank you to Rep. Chris DeLuzio (PA 17) for introducing the "All Aboard Act" into the U.S. House of Representatives for its consideration.

Rep. Deluzio introduced the Act on December 17. Sen. Edward J. Markey (Mass.) introduced the Act into the Senate at the same time.

The Act would dedicate "\$200 billion over five years to build high-speed rail, expand existing passenger rail service. and electrify the most heavily polluting railyards and corridors. The legislation includes critical labor protections for the existing union labor workforce and creates a rail personnel training grant program for rail workers.

"The American people ought to have a rail system that is safe, gets folks quickly where they want to go, and keeps the economy moving - all while slashing road traffic," said Rep. Deluzio when the Act was introduced.

"I am proud to join with Senator Markey to introduce the All Aboard Act to make transformational investments in the Unit- railyard yards in Conway and ed States rail network like electrification. This bill will make American passenger and freight members of our Labor Council.

The Act is supported by numerous labor and community groups. Supporting labor organizations including IBEW, UE, IAM. TWU. AFSCME. Brotherhood of Locomotive Engineers, Brotherhood of Maintenance of Ways Employees Division (BMWED), SMART-Mechanic, and SMART-Transportation.

The New York Times Tech Guild, which represents workers who make the Times' cooking, app, Wordle, and other popular products, donated \$114,000 to the Pittsburgh strike - the remainder from funds that were raised during their own strike in November. The grand gesture stunned the striking workers and came at a time when their funds were running low despite generous donations from supporters around the world over the two-plus years of the work stoppage.

A small portion of the donation from the Tech Guild was used to supplement a modest holiday stipend for the striking workers; the rest of it will go to the strikers who need help paying for essentials such as rent and mortgages, utility bills, vehicle payments and food.
